# **OLD BUSINESS**

The Park District will defer approving any shoreline restoration proposal until after meeting with the City of Oakbrook Terrace to discuss a potential lease extension or renewal for Terrace View Park. A sub-committee comprised of Director Elsey, Commissioner Berkshire, Commissioner Rispens, and Community Liaison Flanagan will represent the Park District in these discussions. An initial meeting between both agencies is tentatively set to take place on Thursday, July 31st at 5:00pm at City Hall.

Over the 4<sup>th</sup> of July weekend, the portable restroom at Heritage Park was vandalized again. The Park District filed a police report with the Oakbrook Terrace Police Department and submitted a Property Loss Report to PDRMA. We also obtained surveillance footage from both Brandywine and Park District cameras, which was shared with PDRMA and the police. Due to the recurring damage and with Board approval, the Park District has removed the restroom for the remainder of the year.
