

ORDINANCE NO. 2014-1120

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES COUNTY Clerk FOR THE OAKBROOK TERRACE COMMUNITY PARK DISTRICT, DUPAGE COUNTY, ILLINOIS FOR F F YEAR 2014

WHEREAS, on the 24th day of July, 2014 a Board of Commissioners of the Oakbrook Terrace Community Park District, DuPage County, Illinois, tentatively approved an annual appropriation ordinance and passed a motion to keep said ordinance on file in the Park District for at least thirty days prior to the final action thereon; and

WHEREAS, on the 24th day of July, 2014, the Board of Commissioners held a public hearing as to said ordinance, prior to final action thereon, notice of which was given by publication in a newspaper having a circulation within the Park District, at least one week prior to the time of such hearing; and

WHEREAS, on the 24th day of July, 2014, the Board of Commissioners of the Oakbrook Terrace Community Park District passed the annual appropriation ordinance of said District for the fiscal year beginning May 1, 2014 and ending April 30, 2015, and upon said date the said ordinance was duly signed and approved by the President and Board of Commissioners of said District and signed by the Secretary of said Board;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE OAKBROOK TERRACE COMMUNITY PARK DISTRICT, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. That the sum of ONE MILLION FOUR HUNDRED FOUR THOUSAND TWO HUNDRED FORTY NINE DOLLARS AND TEN CENTS (\$1,404,249.10) be and same is hereby assessed and levied for and against all of the real property within the limits of the Park District, as the same is assessed and equalized for said taxes, for the year 2014, said total levy being for the various purposes of this Park District more particularly set forth:

That the taxes so levied and assessed as set forth by this Ordinance upon the taxable property subject to taxes within the limits of this Park District, shall be collected and enforced in the same manner and by the same officers as general taxes are now collected and enforced for city and village purposes in the County of DuPage, State of Illinois, and shall be paid over by the officers so collected the same to the Treasurer of the Park District.

SECTION THREE. That the Secretary of this Park District be and is hereby directed to file with the County Clerk of DuPage County, Illinois, within the time limit prescribed by law, a certified copy of this Ordinance.

SECTION FOUR. If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION FIVE. That this Ordinance shall be in full force and effect from and after its passage.
