Payment Authorization

The Oakbrook Terrace Park District requires automatic billing for LEAP Afterschool. Registered participants must provide the Park District with an up-to-date credit card that can be kept on file. **Payment will be processed on the 20th of the month for the upcoming month.** If the 20th falls on a weekend, payment will be processed on the next business day. **A one-time per year \$75 registration fee per student will be charged at the time of registration.**

If monthly payment is declined for any reason, there will be a \$25 Late Fee. Due to so many registrations within the program, unfortunately, we are not able to waive this fee for any reason. Declined monthly payment and Late Fee must be paid by noon the following business day. If payment is not made by the dates indicated, it will result in your child's removal from the program.

If three payments are declined within the same school year or an outstanding balance is not resolved, your child will be suspended from the LEAP program. If you have a lost, stolen, or expired debit/credit card, stolen identity issue, banking problems, etc., it will be your responsibility to notify Alesha Reed the Rentals & Customer Experience Supervisor to update your payment information.
